Dr. Miono Yamamoto, a Emeritus Professor of our Department passed away on May 13th.

The Society of Economics of Kyôto Imperial University held the 23rd Grand Meeting on May 24th and 25th. The days were set near at the Anniversary of the Founding of the Department of Economics.

On the first day's afternoon, a Public Lecture Series was given with great success, the programme being as follows:—

Prof. Dr. Yoshinosuke Yagi, Director : Opening Address.

Prof. Dr. Torazo Ninagawa : Ocean resources in the Far East.

Prof. Dr. Keiji Masai, Kansai University : Pure economic theory and principle of economic control.

Mr. Meido Ando, Director of Hiroshima Revenue Superintendence Office : Financial conditions of the National Government of China.

Prof. Dr. Kichihiko Taniguchi : Closing Address.

The Memorial Dinner-Party was given at the Rakuyukaikan from 6.30 in the same evening, 68 members attended, including Dr. Keiji Masai, Mr. Meido Ando and Emeritus Prof. Masao Kambe. The Party rose at 9 p.m. with perfect satisfaction to all attendance.
