[Overview and purpose of the course]					
<p>In this course, students are instructed in the basic academic skills necessary for writing a master's thesis, such as research design, survey and analysis methods, and how to set research questions (how to formulate questions appropriate to the research purpose and methodology). For students in the GLOCAL program, this course is mandatory and it is not available for students from other programs. [*GLOCAL Students cannot complete "Master Thesis Research" without taking this class and earning credits].</p> <p>This course consists of individual research guidance for each student supervised by each faculty member, and classes and workshops conducted jointly by multiple faculty members. Students will receive guidance based on their individual research topics and plans, as well as learn more general research methods and know-how, and how to write papers.</p>

<p>The goal is for students to be able to apply the content of this class to their thesis writing in a practical way, so that they can independently conceive and prepare their master's thesis based on the content of the class, including basic skills and knowledge about research methods and thesis writing.</p>
